Collection Overview

Acquisition: Family Resources, Inc. donated the items in May 2004. The items had been stored in the basement of the Annie Wittenmyer complex for years, an environment that was humid and not temperature controlled. One additional folder of items was added April 2008.

Access: Materials regarding individuals who obtained service from the Ladies Industrial Relief Society which are **at least seventy-five years old are open** to scholarly and genealogical research with the **exception of Folder 51 in Box 2 and the entire contents of Box 8 due to fragile condition**. Folder 50 contains a copy of the original "Contributions Dec. 1897-Dec. 1902" that should be used in place of the original in Folder 51, and the diaries of Miss Sophie Toller in Box 8 require further conservation due to poor paper quality. See the archivist for questions pertaining to Box 8.
