Electa L. "Lettie" MEACHAM [b. Massachusetts ca 1848 – d. ???]

One of the five ladies who founded the Lend a Hand Club. She, along with Lile Bickford, Dr. Jennie McCowen, May Santry and Anna McCrum started the Club in December of 1886. A section of Sharon Wood's book *Freedom of the Streets* documents Electa's early life and her connection to Dr. McCowen. Lettie and McCowen met at Mt. Pleasant Iowa State Hospital for the Insane before 1877. She left there in 1878 and worked in a paper mill until 1882 when McCowen suggested she come to Davenport and work at the Clarissa C. Cook Home for the Friendless.

1892 *Davenport Daily Leader* article on April 27, page 4, indicates Miss Meacham returned to the Cook Home to become Matron after a year spent in Woodward – possibly at Woodward State Hospital, Woodward, IA.

Appears in several photos in this accession. Also an earlier image of her appears in Sharon Wood's book Freedom of the Streets. [also in 2013-17]

Meacham is listed as the matron in 1910 and 1920 census. She died in Sterling, Whiteside County, IL on May 7, 1926 and was brought to the Davenport crematorium for incineration. One obituary stated she had lived in Sterling for the last ten years. (Obituaries: *Daily Times* Sat. 8 May 1926, *Democrat* 9 May, 1926 page 17.)

Nannie Emeline (GRAY) MAINES was married to Patrick McCullough Maines in 1873. They moved to Clinton, IA in 1876 then lived in LeClaire, Rapid City and Princeton. They are listed in Princeton, IA in the 1880 census with son William Ripley MAINES, who went on to become a successful lawyer and district court judge. The couple did not stay together, but no divorce record has been found as of yet. By 1890 it seems they are no longer living together as Nannie is listed as a seamstress for the Iowa Soldiers Orphans Home.

Patrick, a steamboat engineer, went on to marry and divorce a second time in Davenport-only to die in 1909 while living with son William at 726 West 16th Street. Court documents state he lived with second wife Mary B. until 1901 when he deserted her. He is charged with desertion and nonsupport with the divorce granted in 1904.

Nannie went on to study nursing in Cedar Rapids and then work at a hospital in Clinton, IA from about 1892 until 1898. She is listed as assistant matron at the Clarissa C. Cook Home for the Friendless from 1898 until 1905. Between 1905-1910 she appears to have gone to Pocatello, Idaho to work as a nurse. She returned to Davenport as Assistant Matron for CCCook Home in 1910 and then served as Matron from 1911 until 1918. Photos in 2013-17 w/brothers, sisters, Miss Meacham, Helen Maines

Her life continued in Davenport for a bit, as established in the 1920 census, then in Peoria, IL per 1930's census. Nannie's life ended there in 1939. Her body was brought back to Davenport to be buried at Pine Hill Cemetery next to her former husband, Patrick,

Several images are identified as Mama Maines, and William R. Maines is also identified. 2013-17 child identified as Helen Maines

Anne S. STENT, widow of William H., emigrated from England - arrived about 1887 in the U.S. according to the 1900 federal census. There is no evidence of residence in Davenport prior to 1898 when she is listed in the Davenport city directory as a nurse at the Clarissa C. Cook Home. She appears several more times as employed at the CCCook Home. Then in the 1920 census she is living in Moline with nephew George Innes and his

wife. By 1930 she is listed as an "inmate" at the CCCook Home. Her obituary in the Davenport Democrat on April 30, 1933 states she died at the Cook Home following a short illness. She married Mr. Stent in about 1860 and he died in India in 1871-a sea captain according to her obituary.

The only survivor listed was nephew George Innes. He and Judge William R. Maines joined two other men as casket bearers for Anne Stent's funeral. Her burial was in Riverside Cemetery in Moline, IL.

Stent is identified and I also wonder if the item id'd as "Aunty KENT" might perhaps be her.

Lile F. BICKFORD is not listed as being in any of the photographs, but plays a part in this group. She was born "Eliza" in New Hampshire ca 1854. She evidently worked in several care facilities before coming to the Cook Home when it opened in 1882. She served as Matron for nine years, during which time she helped to establish the Lend a Hand Club in Davenport. One of the businesses that grew from the LAH Club was the Hadlai Heights Women's Hospital. Dr. Jennie McCowen was the chief physician and Miss Bickford served as matron and superintendent, and the two women maintained a close relationship. In 1894 Bickford also took on the vice presidency of Home Cooking business – an early catering venture again sponsored by the Lend a Hand club – while residing at Hadlai Heights Hospital. By 1900 she was needed in Denver, CO to care for her 76 year old mother, Charlotte, and lived with her sister and brother in law Mary S. and John Bartlett Nelson.

Lile's whereabouts in 1910 is still a mystery, but the Nelsons are living in Luna County, New Mexico in both 1910 and in 1920 where we again find Lile living with the couple in 1920.
