The Auditor's Office is legally responsible to have the county plats, but past practice has been to keep a copy in the Assessor's Office as well for checks and balances. The Auditor's office has gone to all digital mapping since about 2010. It was determined that keeping the second hand-drawn copy in the Assessor's office wasn't necessary. Prior to bringing to DPL, all of these items were digitized by the Assessor's office in-house.
