#### Per donor:

"Most of the contents of this box are related to Esther Priscilla BROWNE WILLSON, with some of it related to her son, John Browne WILLSON or her husband, Armour McKibben WILLSON. Esther and Armour lived in Davenport, IA from approximately 1942-1960. Esther Priscilla BROWNE was born in Fairfield, IA and died in Atlanta, GA in 1959. Armour WILLSON then moved back to Fairfield, IA until his death in 1974."

Donor also noted the spelling of the surname BROWN and BROWNE were both used and that WILLSON does indeed have two "L"s.

# **Genealogy Materials**

Materials were transferred from soiled expanding folders to clean, archival folders by KMO'Connor.

Condition: varies; some documents should have individual preservation measures

Ex: handwritten correspondence 1840's 1860's

The identification on the original folders was transferred to the new folders and was not always what was found in the container. Some of the contents were split into two or three archival folders rather than stuffed into one.
